- 1 Specifications of Jersey Woolen Khaki are attached as annexure-"A".
- 2 The shape & design should be as per muster pattern of Police Department. The Muster pattern can be seen at Clothing Store, Police Lines, Sector-26, Chandigarh on any working day.
- 3 The Tender should be accompany earnest money of Rs. 20,000/- in the shape of Call Deposit / Fix Deposit Receipt with each tender on any Schedule Bank only pledged in the name of the Inspector General of Police, U.T., Sector-9, Chandigarh. No tender will be accepted without earnest money and if received after 4.P.M on 21.09.2011
4. The Tender should be sent in a sealed cover marked in bold letter with Sketch pen "TENDER FOR SUPPLY OF JERSEY WOOLEN KHAKI AT 4.00 PM on 21.09.2011 and addressed to the Inspector General of Police, UT, Sector-9, Chandigarh (with Sample).
5. Tender of only those firms who will quote the price of required item as per speciation will be accepted. Firm must attach a latest/fresh test report from Govt. the approved agency/lab that the material quoted by him is in accordance with the required Specifications and Muster Pattern of Chandigarh Police. Non attachment of Test report will liable for rejection of Tender. The test report should be signed/countersigned by the Head of concerned organization. Firm must attach original test report. Photocopy/attested copy will not be accepted and liable for rejection of tender.
6. The material to be supplied by the firm, can be again got tested from the laboratory. If any deviation is found during the test the entire amount of EMD will be forfeited and the firm will be declared black listed.
7. Purchase committee to be nominated by Chandigarh Police can visit the site to inspect the material.
8. Earnest Money shall be valid for a period of 6 months from the date of opening of the Tender by the Purchaser. No interest will be payable by the Purchaser on this amount.
8. The Tender can be accepted /rejected by the competent authority without assigning any reason. The quantity of the items/articles can be increased / decreased at the time of placing supply order.
9. The firm should have registered with the Sales Tax/VAT Department, with respect to Sales Tax/ VAT and shall furnish copies of the same with their Tender.
10. The supply should be completed with in 45 days from the date of supply order.
11. The rate should be quoted F. O. R., destination, including all taxes, if any.
12. The Purchase committee reserves the right to relax any terms & conditions in the Govt. interest.
13. The payment will be made only when the entire supply is received and found fit for use as per the approved specifications/sample, after receiving the test report from Lab.
14. No conditional / Telephonic or Faxed Tenders will be accepted.

16. The firm shall be fully responsible in case any defect is found in the material and should be replace the defective material with in 3 months.
