- iii) Those who are already in occupation of Police Pool house of lower category than the entitlement as mentioned overleaf, if want higher type of house of his entitlement should also need to apply in this form.
- iv) Those who are already in occupation of house but want to **change the same** to some other sector/floor, etc. should apply **in Form-II**.
